FOOTBALL PACKAGE GENERAL INFORMATION

RESERVATIONS/PAYMENTS: Reservations will not be confirmed until full payment has been received.

CANCELLATIONS: Cancellations must be reported in writing to All Seasons Travel. Reservations are completely nonrefundable after 11/10/08. If you cancel, All Seasons Travel will try, but is not obligated, to re-sell your package. In that case, you will be refunded, less a \$50.00 per person handling fee. Name changes will also result in a \$50.00 per person handling fee. No reduction in fare and/or partial refunds can be granted to passengers deviating from the itinerary of the tour. In the event the itinerary is changed before departure, participants will be notified and will have the opportunity to cancel without penalty within five days of notification.

RESPONSIBILITY AND LIABILITY: The Travel Agency has made arrangements for accommodations and services furnished in connection with the tour. The Travel Agency shall be responsible to the tour members as set forth in the brochure, except to the extent such services and accommodations cannot be supplied due to delays, or other causes beyond the control of the Travel Agency. In the event the services and accommodations cannot be provided due to the above reasons or the tour operator amends the itinerary and or accommodations after the tour has commenced, if it is determined to be in the best interest of participants, or in the event services are not used due to voluntary omission by the tour participants, refunds will not be granted. THE TOUR MEMBER WAIVES ANY CLAIM AGAINST THE TRAVEL AGENCY IN THE ABSENCE OF NEGLIGENCE ON ITS PART FOR ANY DAMAGE TO OR LOSS OF PROPERTY OR INJURY TO OR DEATH OF PERSON DUE TO ANY ACT OF NEGLIGENCE OF ANY HOTEL OR ANY OTHER PERSON RENDERING ANY OF THE SERVICES AND ACCOMMODATIONS IN THE GROUND PORTION OF THE ITINERARY. TOUR PRICES: The tour price quoted herein is based upon current rates of exchange and the carrier's current tariffs.
